Booking Information: Average Las Olas safaris sell out 60-120 days in advance, so it is advisable to make your reservations as early as possible. Please confirm availability before purchasing your flight. **Prices do not include airfare. MasterCard, Visa, American Express, checks, and money orders are accepted. Please make checks payable to: Las Olas.** Full payment is required at the time of reservation. Private rooms are available on a first come, first served basis, therefore earlier bookings offer a better choice of rooms. Of course, stowaway roommates are not permitted. You will receive your Safari Confirmation Packet with additional information needed for trip preparation prior to your departure.

Travel and Flight Information: Please book your flights to arrive on the first posted safari date and to depart on the last posted safari date to and from San Jose del Cabo, Mexico. The Las Olas shuttle is available between 12:30pm and 5pm on these days only. If you miss your shuttle, ground transportation via bus or taxi will be at your own expense. Be sure to fill out your flight information above to help us schedule your airport pickup time. Final booking of your flight is not necessary before safari registration. You must bring your valid passport to enter Mexico and return. All guests are responsible for proof of citizenship documents. **Note: Your passport must have at least six months remaining before expiration to be valid.** Minors require special written documentation to leave the country. Detailed information will be provided in your Safari Confirmation Packet. Las Olas provides excellent surfboards, but if you bring your own, contact your airline first to confirm additional baggage charges.

All Las Olas guests must read and agree to the terms of Las Olas' Participant Agreement, Release, and Assumption of Risk form prior to registering for a safari or booking travel arrangements. The Release form is included with this Registration form via download from our website <www.surflasolas.com> or we will gladly fax or mail a copy to you.

Room & Payment Information: You will find up to a bedrooms and a bathroom in rooms. Each Shared Room has twin beds for two guests. Each Private Room has a queen bed for one guest. You may choose the Dawn Patrol discount if you book at least 90 days prior to your arrival date. Please, no exceptions for extending Dawn Patrol discount deadlines.

Cancellation Policy Definitions: "Cancellation" is defined as not attending your scheduled Manifesta safari, including postponing or rescheduling. "You" refers to the guest booking a Manifesta safari. "We" refers to Manifesta Corp. It is your responsibility to read and understand our cancellation policy before making a reservation. Naturally, no one books with the intention of canceling or postponing their safari, but unexpected things do happen, so please consider purchasing travel cancellation insurance.

Travel Cancellation Insurance: Depending on the policy and conditions, travel cancellation insurance will pay for some or all cancellation fees. With most agencies, insurance must be purchased within 14 days of making your reservation. We strongly recommend purchasing cancellation insurance through your travel agent, or visit the following website to compare insurers: <http://www.insuremytrip.com>.

If you cancel or change your safari, Manifesta does not offer cash/check or credit card refunds for any reason. A portion of your payment may be used as credit for another safari within two years of your original safari date. We will gladly transfer your credit to another guest and/or Manifesta safari. Depending on when you cancel, cancellation fees may apply. Fees are determined by the following schedule: If you cancel more than **90 days** before your safari start date, 100% of your payment may be applied to another Manifesta safari. If you cancel **60 - 89 days** before your safari start date, 70% of your payment may be applied to another Manifesta safari. You will forfeit 30% of the price of your safari. If you cancel **15 - 59 days** before your safari start date, 40% of your payment may be applied to another Manifesta safari. You will forfeit 60% of the price of your safari. If you cancel **14 days** or less before your safari start date, you will forfeit your entire payment. Exceptions to our policy cannot be made for any reason, including weather, injury, or personal emergencies. We do not offer credit for arriving late or leaving early. You must submit your signed Reservation Form and Participant Agreement, Release, and Assumption of All Risks Form within one week of booking or 90 days prior to your safari start date, whichever comes later. Guests who fail to do so, may be subject to an automatic cancellation and the above policy will apply.

If we cancel or change your safari, you may transfer your full safari payment to another safari, or you may request a refund of your payments to us, constituting a full settlement. Manifesta is not responsible for your expenses incurred in preparation for any canceled safari, such as airline tickets, loss of work, and/or other costs associated with preparing for your trip.

Participant Agreement, Release, And Assumption Of Risk



In consideration of the services of Manifesta Corporation dba Las Olas and Villa Amor hotel, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "Las Olas"), I hereby agree to release, indemnify, and discharge Las Olas, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that surfing entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: Being hit by the board, other surfers or their boards which could result in cuts, bruises, abrasions, or concussions; hitting the bottom of the ocean; sprains, strains, broken bones, paralysis, even death; exhaustion, dehydration, sunburn; exposure to poisonous and/or carnivorous sea creatures; and accidental drowning. Furthermore, Las Olas instructors have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather, the elements, or the terrain. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks. I understand, that should I become disruptive to the program, rude or abusive to the Las Olas staff or guests, create discomfort for other guests, or disregard safety standards, I will be asked to leave without compensation. Las Olas reserves the right to refuse service to anyone.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Las Olas from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Las Olas' equipment or facilities, including any such claims which allege negligent acts or omissions of Las Olas.

4. Should Las Olas or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

6. In the event that I file a lawsuit against Las Olas, I agree to do so solely in the state of California, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

7. I understand that weather, water, and surf conditions are beyond the control of Las Olas and its agents. Other natural elements such as reptiles, rodents, insects, and micro-organisms such as bacteria and viruses are also an inherent risk on a Las Olas safari and are not grounds for a refund.

8. I understand that from time to time, photographers may take photos of guests for use in promotional materials such as websites, advertisements, catalogues, and magazine editorial. I do not expect any compensation for such use. If I do not want my photograph taken I will inform a representative of Las Olas.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Las Olas on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
